\$2M Grant from Human Resources & Services Administration Awarded for Eastern New Mexico

The Eastern Plains Council of Governments (EPCOG) has been awarded a \$2M grant from the Human Resources & Services Administration (HRSA) with the collaborative efforts of United Way of Eastern New Mexico (UWENM), Initium Health, the City of Clovis staff, and a consortium of more than twenty entities spanning four counties: Curry, Roosevelt, De Baca, and Quay. The grant establishes a four-year program to support behavioral health and mitigate substance use disorder in rural New Mexico. EPCOG will act as the fiscal and oversight agent of the grant program.
